

## Content Recommendations for the Teaching Profile of Evidence Document Teaching Focused Promotions, University of Warwick

Applicants for teaching focused promotions should have available a Teaching Profile of Evidence document to accompany their promotion application. This document should be concise, no more than a few pages long. The document should add detail and evidence of impact to information provided elsewhere in the promotion application rather than provide new information as the document may not always be requested / considered. Impact could be measured in a number of ways, for example, in improved module evaluation scores; increased student numbers; examples of good practice then adopted by colleagues; policy changes at departmental, faculty, university levels; or changes in practice beyond the university either nationally or internationally. Highlighting evidence of external recognition / validation is particularly valuable where this is relevant.

It is helpful to collate information on roles and activities, feedback and impact on an ongoing basis, and then use relevant information from this information set when writing any Teaching Profile of Evidence, Advance HE Fellowship, NTF application etc.

Below are some suggestions of what applicants may want to include in a Teaching Profile of Evidence document. Note that these are only suggestions. Not all of the suggestions may be relevant to any individual promotion applicant. The suggestions are not meant to be exhaustive.

 A summary table of all teaching experience, for example for the most recent three or five years:

- Lists of editing (for example blog, journal or handbook editing); reviewing (for example external department/programme assessor roles, journal article or conference paper review activities); external examiner; WIHEA; professional body; training workshop coordinator roles etc. with evidence of impact in these roles
- Information on administrative/leadership roles related to teaching and learning at departmental, faculty, university and national levels, demonstrating impact in these roles
- Information on personal tutoring roles, numbers of students tutored
- Quotations to demonstrate impact, for example from
  - o PDRs
  - Teaching observations
  - Module evaluation survey results
  - WATE award nominations
  - Advance HE Fellowship / NTF assessors
  - o External examiners
  - Professional body recognition assessors
  - Chairs of faculty / university education committees
  - o SSLCs
