

# Entry is by email only

Each entry must include:

- your completed entry form
- your 3 translations
- your critical reflection (one per portfolio of texts, see below for guidelines)

# **Conditions of entry**

#### **Entrants**

**1.** Entrants must be undergraduate students registered in Modern Languages at a UK higher education institution; the competition is open to students of all nationalities who fulfil this requirement. The competition is open to learners of all language levels.

### **Entries**

2. Entrants are invited to submit a portfolio consisting of English translations of three set texts from one of the following languages: French OR German OR Italian OR Spanish, together with a critical reflection in English (one per portfolio of texts) of no more than 300 words (guidelines for the critical reflections are at (4) below)



- **3.** Each translation must be the original work of the entrant only and not a copy or substantial copy of someone else's translation; it must not have been previously published (including on social media) or broadcast, nor have been submitted as coursework.
- 4. The critical reflection of no more than 300 words should briefly cover such matters as:
  - Issues encountered in translating the texts (e.g. formal/stylistic features, culturally-specific items, considerations of audience)
  - Your approach to translating the texts. What were your priorities and aims? For example, if the original is in a particular form, have you or have you not attempted to preserve that form in English, and what are the reasons for your decision to pursue one approach or another?
- **5.** Entries will be judged without the panel of judges knowing the identity of the competitors, so the translator's name that students will put in the Header of the portfolio will be anonymised before it is sent to the judges.
- **6.** Entries need to sent via email to <a href="m.milani@warwick.ac.uk">m.milani@warwick.ac.uk</a> (Please write in the subject email: Warwick Prize in Undergraduate Translation) and must arrive no later than 5pm (UK time) on **Monday 22 June 2020**.

### Adjudication and prizes

- **10.** The winners of each language category will receive a cash prize and their translations will be published on our website. The copyright of each prize-winning and commended translation and critical reflection will remain with the translator but the Warwick Prize for Undergraduate Translation will have the right for two years to publish and/or broadcast the translations and critical reflections.
- **11.** The Prize will be administered by the Translation Team at Warwick and judged by a team of experts in each of the language areas. Their decision will be final, and the organisers will not enter into any correspondence about the results.
- **12.** The organisers reserve the right to change the judging panel without notice and not to award prizes in a given category if, in the judges' opinion, such an action is justified.
- **13.** The results will be announced on the Translation@Warwick website in mid-November 2020. The winners will be notified earlier, in early October 2020.



**14.** By signing the entry form you give permission for the Warwick Prize in Undergraduate Translation to hold the personal information you have given for the purpose of the 2020 Prize. You have the right to withdraw your consent at any time by sending <a href="mailto:translation@warwick.ac.uk">translation@warwick.ac.uk</a> an email.
