My Interests

“Economics of networks: games on networks, network segregation and homophily, contagion in financial/production networks, network measures of systemic risk, word-of-mouth learning, peer effects, network epidemiology.

Other areas: game theory, industrial economics, models of bounded rationality”

- ▶ Beneficial to pick a topic relatively close to my expertise
 - ▷ Can direct you to relevant parts of the literature
 - ▷ Can quickly spot the potential pitfalls of a given approach

Your Dissertation Topic

Ideally your tutor should contribute in developing your project.

If you pick something far from my interests then it is harder for me to contribute, e.g.

- ▷ Anything in macro!
- ▷ Some areas of finance (e.g. asset pricing, forecasting)
- ▷ Topics with limited economic content

But, the most important 'input' is your effort and dedication

- ▷ Above all pick a topic that you like and find interesting

My Criteria for the Project Outline and Presentation

1. Content

Does your project study an interesting and economically relevant issue?

Does it have potential to make a contribution to the literature?

2. Understanding and Interpretation

Do you make any errors in the design, implementation and interpretation of your project?

Do you effectively communicate the contribution and significance of your results in the context of the literature?

3. Originality

Is your research question/dataset/empirical approach novel or is it a direct extension/replication of other work?

4. Presentation

Are the slides, diagrams and tables clear?

Did you present clearly and confidently?

Literature Review and Project Outline

Our goal for this term:

- ▶ Decide on a topic, write a proposal
- ▶ Complete the literature review
- ▶ Begin data collection

Picking a topic

How should I pick my topic:

1. Start reading broadly, then narrow
2. Read survey articles (JEL, JEP, other surveys)
3. Think about feasibility early

Sources of Survey Articles

- ▶ Journal of Economic Perspectives
- ▶ Journal of Economic Literature
- ▶ Annual Review of Economics
- ▶ Handbooks
 - ▷ e.g. Handbook of Labour Economics, Handbook of Experimental Economics, Handbook of Economic Growth

Some general advice

Don't be too ambitious

Be original, but not too original

The process is just as important as the result

Think about where your project adds value to the literature

Don't panic if you work hard but make no progress
