'Ancient and Continental' A One Day Workshop Call for Papers.

From Nietzsche, Marx, and Heidegger to Foucault, Irigaray, Derrida, and Deleuze, continental philosophers have not hesitated to return to antiquity in order to draw upon ancient philosophical resources for their own work. While not always scholarly, these creative appropriations nevertheless form an important theme within modern European thought. Moreover, they often function as decisive moments in the philosophical development of continental philosophers, moments that deserve close attention. The aim of this workshop is to explore this continuing relationship between ancient and continental philosophy. Contributions on any aspect of this relationship are welcome, whether they be examinations of specific relationships (e.g. Derrida and Plato, Nietzsche and the Presocratics) or more general explorations of the nature of these philosophical appropriations. Contributions are invited for this event scheduled for late Spring 2003.
