- (e) Student Voice: That Dr L Plath and E Worrall had produced a paper on Student Voice and were liaising with the Students' Union on ways to close the feedback loop. The Chair and Secretariat were looking strategically at the issue of getting postgraduate student representation on committees;

(i) That this was being explored with the Faculty of Social Sciences, who are also keen to maximise visibility of modules through potential initiatives such as festivals/events and a review of the Faculty website;

(j) That employability should be considered more broadly than the curriculum and the Faculty should look outside of the University to focus on the destinations and employability of Arts graduates as a whole beyond departmental specific efforts.
