# 14/11-12 <u>Minutes of the previous meeting</u>

#### RESOLVED:

# 15/11-12 Matters Arising

(a) Revisions to University Ordinances and Regulations

## REPORTED:

That the meeting of the Senate held on the 25<sup>th</sup> January 2012 <u>recommended</u> that the proposed amendments to University Ordinance 7 on the Constitution of the Boards of the Faculties be approved with immediate effect as set out in S.20/11-12. (Senate minute 39/11-12)

(d) Revisions to the Constitution and Membership of the Board of the Faculty of Medicine Undergraduate and Graduate Studies Committees

Members were informed, by the Chair, that a formal decision had yet to be made by the Senate regarding the dis-establishment of the School of Health and Social Studies.

## RESOLVED:

That the Chair be asked to update the May 2011 meeting of the Board of the Faculty of Medicine on progress with the formal decision making progress of the dis-establishment, or otherwise of the School of Health and Social Studies.

# 16/11-12 Preparations for the REF

### RECEIVED:

Information from the Chair on the continuing preparations for the REF including a report on the peer review of papers. It being noted that:

- (a) Only 3\* and 4\* ratings would secure funding in this round of the REF
- (b) Research grant income will be measured
- (c) NHS R&D income can be submitted but only if "auditable" and attached to an academic employee of the Medical School
- (d) The "impact" section of the REF will be worth 20% of the total score
- (e) Professor John Davey was the lead for UoA1 with Professor Martin underwood leading on UoA2.

# 17/11-12 Curriculum Review

REPORTED: (By the Head of Education and Development)

On the progress with the MB ChB Curriculum Review noting that the February 2012 meeting of the Board of Undergraduate Studies would be considering a number of modules for the early years of the curriculum, with third and fourth year modules being considered in May 2012 by the Board of

the Faculty of Medicine Undergraduate Studies Committee and then the Board of Undergraduate Studies.
