4/01-02 <u>Matters arising on the minutes</u>

(a) <u>University Strategy for Lifelong Learning</u> (minute 10/00-01 refers)

An oral report from the Chair on the work to date of the group set up by Steering Committee to advise on the University's Strategy for Lifelong learning, noting that although in the academic year 2000-01 the group had focused primarily on the establishment of Foundation Degrees it was intended to address a wider range of issues in the coming year.

REPORTED:

- (i) That the Academic Policy committee had resolved that the periodic review of Open Studies Certificates was sufficiently comprehensive to serve also as a review of the free-standing Open Studies modules (minute 12/00-01 refers).
- (ii) That the proposed new Open Studies Certificates in Music, Transport Studies and Supporting Minority Ethnic Pupils' Achievement were approved by Senate to commence in autumn 2001 (minute 12/00-01(a) refers).
- (iii) That the proposed Open Studies module approval form was approved by Chair's action on behalf of the Academic Quality and Standards Committee (minute 12/00-01 (c) refers).

5/01-02 Open Studies

CONSIDERED:

The annual review of the Open Studies programme for 2000-01 (BLL 3/01-02); it being noted that:

(a) most of the domestic difficulties identified in last year's report had been successfully resolved thanks to the efforts of staff in room bookings and security;

- (b) if the number of classes running successfully was above target for the autumn and spring terms it might mean a reduction in the size of the summer term programme in order to keep within budget for teaching costs;
- (c) the advantages of retaining some non-accredited courses in the programme should be borne in mind even if there was little evidence of student progression from non-accredited to accredited work;
- (d) there was a possibility of offering some of the Warwick Skills Certificate modules as part of the public programme.
