- d) That the EPSRC Interdisciplinary Competition consisted of:
  - (i) Six awards to strengthen research within the Global Priority Programme areas of Innovative Manufacturing; Science and Technology for Health; and Energy, and three further awards for other interdisciplinary science projects.
- e) That the scores allocated to each applicant by scorers were set out in a separate paper (GANC 08/11-12), noting that the average score is presented in the column labelled "Average Score".
