(b) <u>Minute: 4/01-02 Business Studies, Hong Kong</u>

University of Warwick, Senate Minutes, December 2001 resolved:

'That the proposal from the International Office that the HEFP in Business Studies be offered in partnership with the British Council in Hong Kong be approved in principle as set out in paper PDLS 8/01-02, subject to further clarification of the procedures for quality assurance, and that the proposal be forwarded to the Dean of the Warwick Business School for information'.
