RESOLVED:

That, if deemed appropriate, the Acting Dean of Warwick Medical School co-ordinate a response to be considered by the Committee at a future meeting prior to submission by the deadline of 27 February 2009.

211/08-09 Membership of the European Consortium of Innovative Universities (ECIU)

RECEIVED:

A letter from the ECIU confirming that the University had withdrawn its membership with effect from 31 December 2008 (SC.150/08-09).

212/08-09 Policy Update: Admissions and Recruitment

CONSIDERED:

A report from the Director of Student Admissions and Recruitment updating the Committee on issues in undergraduate and postgraduate admissions and recruitment, including the latest applications data (SC.153/08-09).

REPORTED: (by the Director of Student Admissions and Recruitment)

- (a) That the overall undergraduate application position was healthy with an increase of 4.5% on the previous year, noting that it was difficult to deduce whether this represented a rise in early applications or a general increase in applications across the sector.
- (b) That the recent Postgraduate Open Day was a success with a 100% increase in attendance compared to the previous year.
- (c) That the Delivery Partnership Stakeholders conference which took place in November 2008 did not produce any significant new information but confirmed that there would be a 5-calendar day Adjustment Period for confirmation and clearing where applicants who performed better than expected could 'trade up' their confirmed offer to an institution with higher entry standards.
- (d) That discussions had taken place with other institutions and DIUS regarding a 'collaborative Compact scheme' to widen participation, noting that the dialogue had two dimensions:
 - (i) Promoting greater recognition and awareness of the schemes in operation at other HEIs
 - (ii) Creating genuinely collaborative schemes with shared aims and recruitment criteria.

(By the Pro-Vice-Chancellor (Teaching and Learning/International Affairs))

(e) That the University would remain engaged with the Compact scheme discussions to assist in shaping the proposed scheme.

(By the Director of Finance)

(f) That Warwick Business School should be encouraged to consider a second cohort of the MSc in Finance, given the significant increase in applications.

- (a) That the report be approved as set out in SC.153/08-09.
- (b) That the Vice-Chancellor speak with the Dean of Warwick Business School to discuss the possibility of establishing a second cohort of the MSc in Finance.

213/08-09 Financial Performance of ARC Departments: Quarter 1 2008/09

CONSIDERED:

A report from the Academic Registrar providing details of the Quarter 1 outturn for ARC departments considered at the Academic Resourcing Committee at its meeting on 4 December 2008 (SC.156/08-09).

REPORTED: (by the Vice-Chancellor)

(a) That at a meeting last week with representatives from US universities, it was clear that the US higher education sector was experiencing extraordinary financial difficulties.

(By the Academic Registrar)

- (b) That the current variance at the end of Quarter 1 against plan could be largely attributed to two factors:
 - (i) The recent pay award being higher than budgeted
 - (ii) The forecast vacancy savings being lower than expected
- (c) That there was a mismatch in some departments with regards to forecast and actual spend against research income.
- (d) That meetings had been arranged with a number of departments in the coming weeks to address significant variances and downturn against plan, noting that the issues arising from Budget Steering Group were unable to be fully considered at the recent ARC meeting due to the lack of time between the two meetings.

(By the Chair of the Faculty of Arts)

(e) That Heads of Department should be encouraged to consider interdisciplinary appointments to cover vacancies.

RESOLVED:

- (a) That the Academic Registrar and Director of Finance investigate methods for monitoring the ARC budget and that of its departments on a more frequent basis
- (b) That the Vice-Chancellor write to Heads of Departments to restate the need for careful budget management and cost control in the current financial climate, noting that cost savings noted by Departments would be revisited by the ARC.
