- (a) That the Head of Stakeholder Relations and Environment Officer would participate in the focus groups that would form part of the Environmental Association for Universities and Colleges' methodological review process for the Universities that Count survey.
- (b) That it would be valuable to have academic input into the focus groups, noting that the principle of embedding sustainability in the curricula was likely to be considered.

#### RESOLVED:

That academic colleagues who wished to contribute to the focus groups, or who wished to nominate another individual, should approach the Registrar outside of the meeting.

## 76/10-11 The Future of the Quality Assurance System (minute 43/10-11 refers)

#### RECEIVED:

A joint statement from HEFCE, UUK, GuildHE and QAA on the future of the Quality Assurance System (SC.49/10-11).

REPORTED: (by the Registrar)

That the statement included notification of two further forthcoming consultations, those being:

- (a) A HEFCE, UUK and GuildHE consultation on changes to the information that institutions publish about Higher Education,
- (b) A QAA consultation on revisions to the UK-wide Academic Infrastructure.

# 77/10-11 Local Enterprise Partnerships

REPORTED: (by the Deputy Vice-Chancellor)

- (a) That twenty-four successful bids for Local Enterprise Partnerships had been announced, including the Coventry & Warwickshire and Birmingham, Solihull, East Staffordshire, Lichfield & Tamworth partnerships.
- (b) That efforts were underway to secure a high profile Chair of the Coventry & Warwickshire Local Enterprise Partnership.
- (c) That the Government had recently published a White Paper entitled "Local Growth: Realising Every Place's Potential" outlining the Government's new approach to encouraging business investment and promoting economic development, noting that the implications of the paper would be considered by the Committee at its meeting to be held on 8 November 2010.

(by the Registrar)

(d) That there remained ambiguity over how the Local Enterprise Partnerships would be implemented.

## 78/10-11 Pay Negotiations

REPORTED: (by the Registrar)

- (a) That Unison had accepted the offer of a 0.4% consolidated pay increase but that GMB and Unite had rejected it, citing the level of the pay offer and lack of progress on an approach to job security as the key issues.
- (b) That UCEA had been involved in further talks with UCU and EIS through Acas.

#### 79/10-11 Strategic Investment Fund

REPORTED: (by the Deputy Vice-Chancellor)

That Heads of Departments would be invited to make bids to the University's Strategic Investment Fund, established to invest in initiatives that meet strategic aims in research and teaching, noting that further information would be published online through Insite.

#### 80/10-11 Early Student Statistics

#### CONSIDERED:

A report from the Academic Registrar and the Senior Assistant Registrar (Management Information & Planning Office) concerning postgraduate and undergraduate enrolments against budget and plan, together with an oral report (SC.47/10-11).

REPORTED: (by the Academic Registrar)

- (a) That a total increase in fee income of £2.39m was predicted against plan, given enrolments and re-enrolments at this stage in the year.
- (b) That there were significant increases in undergraduate student numbers (primarily Home/EU), resulting in an overall overshoot of 393 students against planned target.
- (c) That student numbers on government-supported postgraduate taught courses were higher than forecasted (123 students above planned target).
- (d) That recruitment for independently-funded postgraduate taught courses was significantly below-plan, for both Home/EU (undershoot of 24) and Overseas (undershoot of 108).
- (e) That a shortfall in postgraduate research numbers against plan, across both Home/EU and Overseas students, did not take account of in-year recruitment.

(by the Chair of the Board of Graduate Studies)

(f) That there was some lack of clarity relating to continuing government funding for Band D postgraduate taught courses.

(by the Dean of Warwick Medical School)

(g) That recruitment to the MBChB course was potentially a future issue for consideration, noting that numbers of newly qualified doctors nationally now exceeded the number of vacant positions.

(by the President of the Students' Union)

(h) That it was important that the potential for strain on campus facilities was considered in the context of an increasing student population.

#### RESOLVED:

That the Senior Assistant Registrar (Management Information & Planning Office) liaise with the Chair of the Board of Graduate Studies to clarify the funding of Band D postgraduate taught courses.

#### 81/10-11 Widening Participation Strategic Assessments

#### CONSIDERED:

A letter from the HEFCE, clarifying their expectations of widening participation strategic assessments (SC.53/10-11).

REPORTED: (by the Academic Registrar)

- (a) That the University was compiling its annual monitoring return for Access Agreements and Widening Participation Strategic Assessments, to be submitted to HEFCE by 14 January 2010 2011.
- (b) That recruitment to the currently vacant post of Assistant Registrar (Widening Participation) would assist in ensuring that the University's work in this area was aligned with HEFCE requirements.
- (c) That the Acting Director of Student Admissions and Recruitment would identify current widening participation activity being undertaken within departments, acknowledging that more stringent adherence to HEFCE's guidelines may be required in future.

(by the Dean of Warwick Medical School)

(d) That Widening Participation was a particular challenge for the Warwick Medical School in the context of the MBChB programme being graduate entry only.

(by the Registrar)

(e) That continued dialogue with the Centre for Lifelong Learning may prove useful in providing insights and advice to departments.

That the University's annual monitoring return for Access Agreements and Widening Participation Strategic Assessments be considered by the Steering Committee prior to its submission to HEFCE by 14 January 2010 2011, noting that the Committee would be kept up to date with any actions arising from the HEFCE letter (SC.53/10-11).
