8/16-17 Safeguards to Horizon 2020 Funding

15/16-17 Policy on Discounted Ensuite On-Campus Accommodation for Students with Disabilities

(a) That the paper and proposed policy related to the provision of discounted, ensuite on-campus accommodation for students with disabilities, to address the University's obligation to enable reasonable adjustments.

- (b) That the policy was being proposed in response to the recent government changes to the Disabled Student Allowances (DSA), resulting in the removal of funding for ensuite accommodation for students with disabilities.
- (c) That in accordance with the Equality Act 2010, the University was required to make reasonable adjustments, with the provision of ensuite accommodation considered to be such an adjustment.
- (d) That the policy would apply to all students at the University who required access to on-campus ensuite accommodation on disability grounds, rectifying a historical inequality for EU and international students.
- (e) That as disabled students requiring adjustments were accommodated oncampus, the provision of off-campus accommodation was outside the scope of the proposed policy.
- (f) That it was estimated that 300-350 students would be supported.

(g) That he wished to commend the proposal, which promoted a very positive message.

(h) That the cost of the proposal, based on the previous year's figure, was c. £340k.
