**RESOLVED:**

329/06-07 2007 Royal Society Medals and Awards (minute 309/06-07 refers)

REPORTED:

(by the Pro-Vice-Chancellor {Research})

(a) That further updates on the preparation of nominations for the 2007 Royal Society Medals, Awards, Prizes and Prize Lectures were being sought from Research Support Services but that a call for nominations by departments within the Faculty of Science had drawn little response.

(by the Vice-Chancellor)

(b) That he expected that the University would be putting forward nominations for the Royal Society's Medals, Awards, Prizes and Prize Lectures by the deadline of 21 February 2007.

330/06-07 Consultation on European Credit System for Vocational Education and Training (minute 319/06-07 refers)

REPORTED: (by the Registrar)

That the Senior Assistant Registrar (Teaching Quality) would be determining whether the University should respond to the European Commission Consultation on its proposals for a European Credit System for Vocational Education and Training.

## 331/06-07 Study Leave (minute 310/06-07 refers)

That the Biotechnology and Biological Sciences Research Council had notified the University of its approval for the continuation of WHRI funding through the BBSRC core strategic grant.

## 333/06-07 International Issues

That he had made an approach to a potential Interim Director of the Institute for Advanced Study, that the individual concerned was currently considering appointment to the position and that he expected that a proposal for appointment would shortly be brought forward for consideration by the Steering Committee.
